Parcel D

All that certain piece or parcel of land situated northerly of Hidden Lake Road in the Town of Haddam, County of Middlesex, and State of Connecticut, shown as Parcel D on a map entitled "Map for Hidden Lake Association Town of Haddam, Connecticut November 1, 1991 Rev. Oct. 29, 1993" a class A-2 survey by Richard J. Ziobron, L.S. No. 11355, which map is to be recorded in the Haddam Town Clerk's Office and which parcel is more particularly bound and described as follows:

Commencing at a point marked "I.P.", which point marks the northwesterly corner of the hereindescribed premises and the southwesterly corner of Parcel C as shown on said map; thence running in an easterly direction along Parcel C as shown on said map S 52-20°-12" E a distance of 45.00 feet to a point which marks the northeasterly corner of the hereindescribed premises, the southeasterly corner of Parcel C, the southwesterly corner of Parcel F and the northwesterly corner of Parcel B as shown on said map; thence turning and running in a southerly direction along Parcel B S 46-24'-37" W a distance of 10.00 feet to a point; thence continuing in a southerly direction along Parcel B S 24-17'-05" W a distance of 56.70 feet to a point which marks the southeasterly corner of the hereindescribed premises and the southwesterly corner of Parcel B as shown on said map; thence turning and running in a westerly direction along a curve to the left with a radius of 330.0 feet a distance of 20.45 feet to a point marked "Conc. Mon. Fd." as shown on said map; thence continuing along said curve a distance of .242 feet to a point marked by an "Iron Pin Set", which point marks the southwesterly corner of the hereindescribed premises; thence turning and running in a northerly direction along land now or formerly of Langmaid N 15-33'-02" E a distance of 75.11 feet to the point or place of beginning.

Said Parcel D contains 2,400.4 square feet or .0551 acres, as shown on said map, and is subject to a bridge maintenance easement, as shown on said map.

No. 11355, which map is to be recorded in the Haddam Town Clerk's Office and which parcel is more particularly bound and described as follows:

Commencing at a point marked "Conc. Mon. Fd." which point marks the southwesterly corner of the hereindescribed premises and the southeasterly corner of Parcel B as shown on said map; thence running in a northerly direction N 26-44"-49" E along Parcel B a distance of 51.72 feet to a point, which point marks the northwesterly corner of the hereindescribed premises, the northeasterly corner of Parcel B and the southernmost corner of Parcel A as shown on said map; thence turning and running in southeasterly and southerly directions along other land of Hidden Lake Association, the following courses and distances: a) S 38-01'-40" E a distance of 25.68 feet; b) S 23-34'-58" E a distance of 35.24 feet; c) S 41-54'-03" E along a stone wall a distance of 15.72 feet to an "Iron Pin"; d) S 2-17'-43" W along a stone wall a distance of 33.42 feet to a point marked "Brill Hole In Stone", which point marks the southeasterly corner of the hereindescribed premises; thence turning and running in a northwesterly direction N 84-29'-33" W a distance of 19.02 feet to a point marked "Conc. Mon. Fd."; thence turning and running in a northwesterly direction along a curve to the left with a radius of 330.0 feet a distance of 66.04 feet, to the point or place of beginning.

Said Parcel El contains $3_{\rm x}126.0$ square feet, or .0717 acres, as shown on said map.
